

Digital Art Purchase Policy

This Digital Art Purchase Policy governs the purchase and use of digital and musical art goods (the "Products") from Oktonec ("we," "us," or "our"), an independent art creator based in Quebec, Canada, through our website www.oktonec.com (the "Site"). We use our platform to promote and showcase our art in North America and globally. By purchasing and downloading our Products, you agree to be bound by this policy.

1. Purchase and Licensing

Important Notice: When you "buy" or "purchase" a Product from our Site, you are not acquiring ownership of the Product. Instead, you are purchasing a license to use the Product in accordance with the terms set out in this policy. We retain all rights, title, and interest in and to the Products, including all copyrights and intellectual property rights.

By completing your purchase, you affirmatively acknowledge that you understand you are receiving a license and agree to the restrictions and conditions of that license.

2. License Grant

Upon purchase, we grant you a non-exclusive, non-transferable, revocable license to use the Products for your personal, non-commercial use only.

This license strictly prohibits: * **Redistribution or Resale:** You may not reproduce, redistribute, transmit, sell, broadcast, rent, share, lend, modify, adapt, edit, or sublicense the Products in any form. * **Commercial Use:** You may not use the Products for any commercial purposes, including but not limited to public performance, advertising, or inclusion in any product or service that is sold or monetized. * **Creating Derivative Works:** You may not create any derivative works based on the Products.

Upon successful completion of your payment, your Products will be made available for download. A download link will be provided on the confirmation page and/or sent to the email address associated with your purchase. Please ensure you provide a valid email address.

We may limit the number of times you can download a Product. It is your responsibility to download and securely store the Product promptly after purchase.

4. Refund Policy

Due to the digital nature of our Products, they are delivered instantly upon purchase and cannot be returned. Therefore, **all sales of digital and musical goods are final and non-refundable.**
